

## Cohesion Policy 2007-2013 • Italy




EU-25: Convergence and Regional Competitiveness and Employment Regions 2007-2013

The current programming period will come to an end in December 2006. The Commission, the Member States and the regions are preparing for the new programmes for 2007-2013. The renewed cohesion policy and its instruments constitute about one third of the EU budget. Priority is given to less developed Member States and regions. The new policy will aim to promote growth-enhancing conditions for the Union's economy and will focus on three new future objectives: convergence, competitiveness and cooperation.

ELIGIBLE REGIONS Convergence Objective: Calabria, Campania, Puglia, Sicilia. Statistical phasing-out: Basilicata. Phasing-in: Sardegna. Competitiveness and Employment Objective: all the other regions. Between 2007 and 2013, in Italy, a population of **17,37 million** (30,2% of the total population) will live in "Convergence" regions (including 0,60 million or 1 % in "statistical phasing-out" areas). Between 2000 and 2006, **19,01 million** (33%) lived in regions supported under "Objective 1".
